SHAPING OUR FUTURE



The third President's Perspective for this year is about shaping our future. This Association has a long history of contributing to the development of future generations through various programs including the Mentor/Mentee program, the Regional High School Mock Trial Tournament, and the Laptop from Lawyer's program.

In this President's Perspective, I want to ask everyone to continue this Association's great contributions to the development of future generations and tell you about upcoming opportunities to further shape our future.

Since 2014, the Association has been contributing to the development of new attorneys through its Mentor/Mentee program. The program was organized on the belief that that a mentorship relationship should be mutually beneficial to both the mentor and mentee. This year, the Chairs for the Mentor/Mentee Committee, Carolyn Wiley and Graham Hersh, have decided to revamp the offerings of the program.

Earlier in the year, Jersey Green offered the Mentor/Mentee program a great opportunity by agreeing to provide new attorneys free one-on-one coaching to allow them to develop their practice skills. On January 16, 2019 from 6:00 p.m. to 7:30 p.m. at Maggie Smith's Irish Pub (6631 S. Peoria Street, Englewood, Colorado), the Mentor/Mentee program is also offering mentors and mentees an opportunity to "Greet and Grow" through a speed dating for mentorship event. This opportunity will allow mentors and mentees to meet and form organic connections with individuals that can provide a mutually beneficial mentoring relationship. I encourage both mentors and mentees to sign up for this fun event. Drinks and appetizers will be provided to all who sign up. Students and non-members are welcome!

The Association has also contributed to shaping our future through its participation in the Regional High School Mock Trial Tournament on an annual basis. The High School Mock Trial Program offers high school students an opportunity to improve a number of skills including their public speaking and critical thinking skills. The program also teaches students the importance of teamwork. Each year, the Association needs volunteers to help judge, score, and monitor the regional competition. This year's competition is February 22nd and 23rd at the Arapahoe County Justice Center. Finally, the Laptop from Lawyers program, which is the signature program supported by the Arapahoe County Bar Foundation, has been a longstanding program that has allowed our members to contribute to the development of future generations. MEMBER SPOTLIGHT

Michael P. Miller



In its sixtieth year, the Arapahoe County Bar Association is reflecting on its roots and history, not only to understand its beginning and how it got to where it is now, but also to help map the future of the organization. The ACBA members are its lifeblood and the engine that continues to make the organization as powerful as it is; without its members the ACBA does not exist. The ACBA owes its existence and success to its pioneering members.

While every member has a role to play in the organization, one member of the ACBA has worked tirelessly in helping to create the organization as we know it and continues to have a hand in its direction and future.

Michael P. Miller has been a member of the ACBA since 1978 and has filled almost every role (including serving as President) and has received nearly every award that the ACBA offers (including the Tommy Drinkwine Outstanding Young Lawyer of the Year Award). While the positions and the awards are a testament to Mike's dedication and commitment to the ACBA, the legal community, Arapahoe County

and the State of Colorado at large, Mike's contributions to the ACBA continue to be felt today.

Mike's father, Martin (Marty) Miller (1924-2007) was one of the original founders of the ACBA who as a District Court Judge for the then 1st Judicial District, called from the bench to have the Arapahoe County lawyers form their own Bar Association. Mike stepped into the shoes of a bar leader and helped work to bring the ACBA to the next level of success. Michael has been instrumental in introducing and helping to incorporate modern initiatives and programs into the bar.

Prior to serving as an officer with the ACBA, Mike helped fund and produce a 35-minute video production captioned "The Birth of the Bar." This film produced by the UC Denver Film and Theatre Department, interviewed every surviving founder of the ACBA and captured many of their thoughts and memories of the early days of the ACBA. This film is a must see and is available on the new ACBA web page.

When Mike served as President Elect, he was the first ACBA member to attend the Bar Leaders Institute conference in Chicago hosted by the American Bar Association. During this event, he discovered that the ACBA was the largest bar association in the country without a dedicated executive director. With this revelation and upon Mike's insistence, the ACBA hired its first executive director, and continues to rely on amazing and dedicated people to help run and manage the day-to-day operations of the ACBA. The hiring of an executive director has allowed the ACBA to continue to offer the services, programming, and events that the members expect, and has made the ACBA one of the leading bar associations in Colorado.

Mike has also worked to implement another signature program of the ACBA which is the Arapahoe County Bar Foundation. Mike worked, pushed, pulled, and assisted in the creation of the Bar Foundation and its signature program. This organization's mission, among other charitable endeavors, is to raise money for the "Laptops from Lawyers" program that gives laptop computers to deserving high school students in Arapahoe County who, but for this award, would be attending college or university without a laptop computer. Since its inception, the ACBF has given away over 200 laptops to deserving students. Much like the decision to hire an executive director, the Bar Foundation organization is a program that is a model program that continues to set the ACBA apart as a leading bar association in Colorado.

Mike continues to this day to play an integral role in the management and organization of the Arapahoe Bar Association and sits as the Chair of the Arapahoe County Bar Foundation. As importantly, Mike fills an important role as a "keeper" of the knowledge that is a critical link between the history and future of the bar. Retaining and understanding the history of the bar is critical to the future of this outstanding organization.

The ACBA owes a debt of gratitude to many members, originators, pioneers, and leaders like Michael Miller. Thank you for everything that you have done, and continue to do, for the Arapahoe County Bar Association, the Arapahoe County Bar Foundation, Arapahoe County, and Colorado.

LAWYER WELLNESS

The ABA National Task Force on Lawyer Well-Being released its omnibus report a little over a year ago, outlining the “wellness” challenges facing lawyers, judges, and law students nationwide. A copy of the report can be found online here: [National Task Force on Lawyer Well-Being](#). Our own Jim Coyle, former Regulation Counsel with the Colorado Supreme Court, was a co-chairman of the Task Force. That Report provides illumination on the pervasive nature of the wellness issues facing lawyers across the country and here in the 18th Judicial District.

The Task Force Report laid out a framework of suggestions for various “stakeholders”, including local bar associations like the Arapahoe County Bar Association (“ACBA”). The ACBA has decided to focus on the needs of our members as it relates to Lawyer Wellness under the leadership of the Honorable Echo Ryan, ACBA’s President. The ABA Report Included in the recommendations applicable to the ACBA as follows:

- Acknowledge the existence of problems within the ACBA;
- Take responsibility to address wellness issues in our community;
- Call leaders within the ACBA to make personal commitments to wellbeing;
- Engage in conduct to “destigmatize” wellness issues and facilitate and encourage help-seeking behaviors;
- Foster collegiality and respectful engagement over wellness issues;
- Provide high quality educational programs and materials about lawyer well-being;
- Guide and support the transition of older lawyers;
- Begin a dialogue about suicide prevention;
- Serve as an example of best practices relating to lawyer well-being at bar association events; and
- Launch a lawyer well-being committee within the bar association.

As noted, President Ryan has given her full-hearted support and leadership to implementing the recommendations of the Task Force within the ACBA. The Board of Directors of the ACBA, as well as the Committee Chairs of the ACBA, have voiced their desire to support President Ryan’s call to action. It is the intention of the ACBA to engage in purposeful and meaningful action over the coming months and years to engage on all of the issues raised by the Task Force.

One of the first steps President Ryan took in this regard was the formation of a Committee on Lawyer Well-Being within the ACBA. That Committee is charged with the responsibility to formulate a mission statement for the ACBA on this important topic and outline various steps that can be taken to provide wellness assistance to our members. In the coming months and years it is the desire of the Committee to open the dialogue about lawyer wellness and begin the process of helping our members deal with the myriad of well-being issues they face. A non-exhaustive list of issues includes: mental health issues such as stress, depression, and anxiety; work-life balance; substance use and abuse including addiction and recovery; and end of practice issues related to performance, transition, and client protection. The Committee is open to suggestions and offers of assistance as we explore these (and other) well-being issues.

Lawyer wellness is a pressing concern in the 18th Judicial District. The leaders and members of the ACBA are committed to exploring, destigmatizing, and discussing lawyer wellness issues, and to enhancing lawyer wellness wherever possible. We invite you to join with us in this journey.

Presiding Judge: This volunteer role is a current or retired Colorado Judge or an expert mock trial volunteer. During the competition the presiding judge acts as the voice of the panel, controls the conduct of the courtroom and trial participants, and supervises the time constraints imposed by the rules of competition. The presiding judge rules on motions and objections based on the rules of evidence. The presiding judge does not announce a verdict on the legal merits of the case, but in all other respects conducts the trial as if it were a real trial.

Scoring Panelist: Three attorneys, paralegals or community members comprise the scoring panel. The score is based on presentation and not on the legal merits of the team's case. A scoresheet is completed.

Courtroom Monitor: This individual normally is a member of the public, employed at the courthouse, or any other volunteer that doesn't wish to score or judge a round. This is a very important role for a smooth tournament overall.
